CRITERIA FOR NOMINEES

- Must be a REALTOR® member in good standing.
- Must be a Primary member of the Local Association
- Service must be a non-business endeavor
- Award recipient may win only once in a lifetime
- Service shall be recognized not for financial contributions but for service contributions
- Award recipient shall not be a full-time employee of the charity or be compensated for any work or service
- Some portion of the nominee's community work must have taken place during the previous year.
